BATTERING INTERVENTION PROGRAM





Renewal Treatment, Inc. (RTI) offers a 24-session cognitive-behavioral Battering Intervention Program to individuals referred through the courts, probation, or Children Youth and Families. The curriculum focuses on changing learned behaviors that are abusive and violent by presenting alternatives essential to building and maintaining healthy relationships with intimate partners, children, family and friends.

- Group services are conducted at the Renewal Reentry Center, 700 Fifth Avenue, Pittsburgh, PA
- Each group meets twice a week for two hours for 24 sessions over 12 weeks.
- Attendance and payment compliance for all 24 sessions are required for successful completion of the program.

Battering Intervention Program Intake and Assessment Process:

- Self-referrals are accepted by phone.
- Court, probation and other referrals are accepted by phone, fax, and email.
- An individual intake appointment must be scheduled allowing 60 to 90 minutes for the appointment.
- A one-time intake Fee of \$15 is payable at the intake assessment (Cash, check or money order payable to: Renewal, Inc.). Receipt given and payment record established.
- Payment is based upon a sliding fee scale. Co-payment for each group session is required.
- Current pay stub (last 30 days) is required if employed.
- Documentation of alternative sources of income and support is required to determine co-payment fee (SSD/ SSI, cash, assistance, etc.)
- Individuals with no income and unemployment must provide a notarized letter from the person who provides food and shelter.
